PHARMACY, T.N. PALAYAM



This MOU is entered into the date of 04/09/2022 by and between JKK Munirajah Institute of Health Sciences College of Pharmacy (hereinafter called JKMIHSCP) situated at T.N. Palayam, Erode District (Tamil Nadu), an Institute of national importance established by special act of Parliament of Republic of India

and

PPG College of Pharmacy, Coimbatore (hereinafter called PPGCP), Pharmacy college under The Tamilnadu DR MGR Medical University, Chennai. The aforesaid Institutions are hereinafter referred to individually as institute and collectively as institutes.

1. Objectives of the MOU

- a) To promote and enhance academic interest between JKKMIHSCP & PPGCP.
- b) To provide advice for implementation of quality of education at JKKMIHSCP & PPGCP
- c) To promote research/continuing education activities between Institutions.

2. Technical Areas of Collaboration:

- a) A Continuing Quality Improvement Programme to improve quality of teaching staff at PPGCP through short-term/long-term certificate courses at JKKMIHSCP. Faculty of JKKMIHSCP could also be sent to PPGCP for necessary guidance.
- b) Provide academic interaction by delivering Special Lectures at PPGCP on topics of relevance to modern Industry.
- c) Provide necessary help in Organizing Workshops/conferences and Personality Development Programmes at JKKMIHSCP for enhancement of skills in respect of Faculty, Staff and Students of PPGCP.
- d) Usage of academic infrastructure of JKKMIHSCP for PPGCP students and faculty members.
- e) To facilitate the training for teachers and PG students.
- f) Jointly supervision of PG thesis as per The Tamilnadu DR MGR Medical University, Chennai.


3. Proposed Modes of Collaboration:

JKKMIHSCP and PPGCP propose to collaborate through the following:

- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between JKKMIHSCP and PPGCP. A specific plan will be worked out by the institutes depending upon availability of resources. A specific agreement will be entered into for each activity.

4. Terms and Conditions:

- a) For continuing education to PPGCP teachers and students, the financial arrangements will be made mutually agreed terms.
- b) The faculty members and students of PPGCP can use the library facility of JKKMIHSCP for short-time.
- c) Both institutes agree to help, identify and Invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.
- d) This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- e) Either Institute shall have the right to terminate this MOU upon 60 days prior written notice to the other Institute.

5. Confidentiality:

a) The JKKMIHSCP and the PPGCP agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.

b) The above confidential clause under this MOU excludes the information/data possessed by either institute before entering into this MOU or independently developed and/or information already available through public domain.

6. Duration of MOU:

This MOU, unless extended by mutual written consent of the institutes, shall expire in years after the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another one years by mutual consent.

7. Intellectual Property Rights:

The intellectual property rights (IPR) that arise as a result of joint research and collaborative activity under the agreement will be worked out on a case to case basis and will be consistent with officially laid down IPR policies of the two institutes.

9. Signed in Duplicate:

This MOU is executed in duplicate with each copy being an official version and having equal legal validity. By signing below, the institutes, acting by their duly authorized officers, have caused this Memorandum of Understanding to be executed, effective as of the day and year first above written.
