MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

This MOU is entered into the date of 28/01/2021 by JKK Munirajah Institute of Health Sciences College of Pharmacy (hereinafter called JKKMIHSCP) situated at T.N. Palayam, Erode District (Tamil Nadu), an Institute of national importance established by special act of Parliament of Republic of India

and

St. Mariam College of Pharmacy, Tirunelveli, a Pharmacy college affiliated to The Tamilnadu DR MGR Medical University, Chennai. The aforesaid Institutions are hereinafter referred to individually as institute and collectively as institutes.

1. Objectives of the MOU

- a) To promote and enhance academic interest between JKKMIHSCP & St. Mariam College of Pharmacy.
- b) To provide advice for implementation of quality of education at JKKMIHSCP & St. Mariam College of Pharmacy
- c) To promote research/continuing education activities between Institutions.

2. Technical Areas of Collaboration:

- a) A Continuing Quality Improvement Programme to improve quality of teaching staff of St. Mariam College of Pharmacy through short-term/long-term certificate courses at JKKMIHSCP. Faculty of JKKMIHSCP could also be sent to St. Mariam College of Pharmacy for necessary guidance.
- b) Provide academic interaction by delivering Special Lectures at St. Mariam College of Pharmacy on topics of relevance to modern Industry.
- c) Provide necessary help in Organizing Workshops / Conferences and Personality Development Programmes at JKKMIHSCP for enhancement of skills in respect of Faculty, Staff and Students of St. Mariam College of Pharmacy.
- d) Usage of academic infrastructure of JKKMIHSCP to St. Mariam College of Pharmacy students and faculty members.

3. Proposed Modes of Collaboration:

JKKMIHSCP and St. Mariam College of Pharmacy propose to collaborate through the following:

- a) Cooperation and promotion of education and training in areas of mutual interest.
- b) Any other appropriate mode of interaction agreed upon between JKKMIHSCP and St. Mariam College of Pharmacy. A specific plan will be worked out by the institutes depending upon availability of resources. A specific agreement will be entered into for each activity.

4. Terms and Conditions:

- a) For continuing education to St. Mariam College of Pharmacy teachers and students, the financial arrangements will be made as per mutually agreed terms.
- b) The faculty members and students of St. Mariam College of Pharmacy can use the library facility of JKKMIHSCP for short-time.
- c) Both institutes agree to help, identify and invite the faculty members and researchers from the other institutes to participate in conferences, workshops and short-term courses.
- d) This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- e) Either Institute shall have the right to terminate this MOU upon 60 days prior written notice to the other Institute.

5. Confidentiality:

a) The JKKMIHSCP and the St. Mariam College of Pharmacy agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.

b) The above confidential clause under this MOU excludes the information/data possessed by either institute before entering into this MOU or independently developed and/or information already available through public domain.

6. Duration of MOU:

This MOU, unless extended by mutual written consent of the institutes, shall expire after 10 years and the effective date specified in the opening paragraph. However, on review, the MOU shall be extended for another one year by mutual consent.


7. Intellectual Property Rights:


