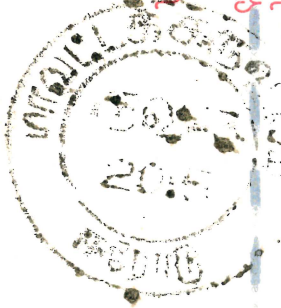

1. Purpose

The purpose of this MoU is to establish a framework for collaboration and cooperation between The College and The Company in the following areas:

1.1 **Training and Internship:** The Pharmacy may provide opportunities for students of The College to undertake internships for B. Pharmacy students with practical training opportunities at the Pharmacy, allowing them to gain real-world experience in the field of community pharmacy.

1.2 **Knowledge Sharing:** The Parties may exchange knowledge, expertise, and information related to pharmaceutical sciences through seminars, workshops, and other educational events.

2. Term

This MoU shall be effective as of the date first above written and shall remain in force for a period of **Three years** from the Effective Date (**19.03.2020**). This MoU may be extended or renewed by mutual written agreement of the Parties.

3. Responsibilities

3.1 **The College Responsibilities:** The College agrees to:

- a. Identify suitable students for internship opportunities at the pharmacy.
- b. Encourage faculty and students to actively participate in collaborative training activities.
- c. Promote and facilitate academia interaction events.

3.2 **Faculty Support:** The College may provide faculty members to facilitate training sessions or workshops at the Pharmacy, subject to mutual agreement.

3.3 **The Company Responsibilities:** The Company agrees to:


The Pharmacy shall provide a conducive environment for the practical training of B. Pharmacy students, ensuring they gain relevant experience and exposure to community pharmacy practices.

4. Duration of Collaboration:

This MOU shall be in effect for a period of **3 years** from the date of signing, commencing on 19-March, 2020, and concluding on 19-March, 2023.

5. Amendments:

Any amendments or modifications to this MOU must be made in writing and signed by both Parties.
