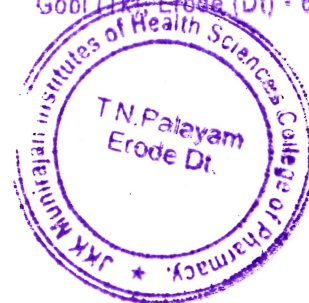



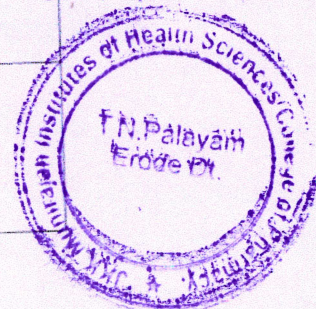
**ORDER:-**

5. The written complaints from the victim woman of this University shall be directly received by the Presiding Officer of the Committee.

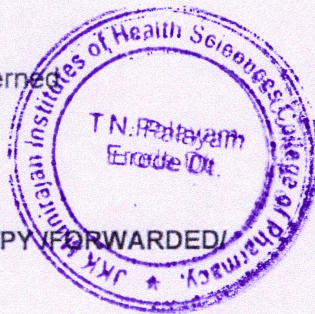
6. The External Members shall be paid Honorarium for attending the Committee Meeting as per existing rules in force.
